PLACE FROZEN ROLL DOUGH, SMOOTH SIDE FACING DOWNWARD, ON PARCHMENT LINED BAKING SHEET. DOWNWARD, ON PARCHMENT LINED BARING SHEET.

BAKE TIMES WILL VARY BY OVEN TYPE AND QUANTITY
OF PRODUCT IN OVEN. ROLLS ARE FULLY BAKED WHEN
CENTER CURL SPRINGS BACK WHEN LIGHTLY TOUCHED.
ALLOW TO COOL IF ICING OR FINISHING. Great low-prep bakery item which allows for flexible usage in the cafeteria, kiosks, grab on the go and lunch menus.
